RULES AND REGULATIONS

ENTRY FEE: \$25.00

AGES: 16-21

1. **ALL CONTESTANTS MUST HAVE THEIR BIRTH CERTIFICATE OR COPY WITH THEM AT TIME OF ENTRY.**
2. *The winner must fill out state forms the night of the pageant. Prize money will be held in the Fairgrounds office until all forms have been filled out for the state pageant.*
3. The winner should attend the county fair as many nights as possible, **BUT HAVE TO ATTEND THE COUNTY FAIR ON SATURDAY NIGHT, JULY 11, 2009.**
4. Contestants will show in one piece swim suits and second in formal attire.
5. Contestants must be a full time student in an accredited Kentucky school system.
6. Contestants must have reached her 16th birthday by October 31st, and cannot have reached her 22nd birthday by November 1st of the year the pageant is held.
7. There will be one winner, 1st runner-up and 2nd runner-up.
8. Contestants will pay an entry fee of \$25.00. Checks should be made to the Ewing-Fleming County Fair.
9. Rehearsal will be Sunday, July 5, 2009 at 8:00 PM at the Ewing-Fleming County Fair Grounds.
10. Deadline for entry is Sunday, July 5, 2009 at rehearsal.
11. The winner will be acclaimed "Miss Ewing-Fleming County Fair" and reign as queen throughout the year and represent Ewing-Fleming County Fair at the State Pageant of the Kentucky Association of County Fairs, competing for the title of "Miss Kentucky County Fair". The Pageant will be held in January 2010 in Louisville, Kentucky.
12. The contestant must be single, never married, never had a marriage annulled and never has had a child.
13. If an contestant holds a 2009 title from another county fair, belonging to the Kentucky Associations of Fairs and Horse Shows, he or she is ineligible to compete in our pageant.
14. Anyone winning the Miss Kentucky County Fair Competition is ineligible to compete in the Ewing-Fleming County Fair pageant or the State pageant thereafter.
15. There will be a 5 minute individual interview before the pageant beginning at 5:30 PM. **Each contestant will have an individual time to be there for their interview, these times will be given out at rehearsal; there will be no make time available. If contestant is not there for their scheduled interview time they will not get an interview score.**
16. Contestant will be judged 30% beauty and appearance, 30% poise and confidence, and 40% interview.
17. Prizes: The winner will receive \$125.00, tiara, sash, flowers, crystal picture frame and trophy. 1st runner-up will receive \$75.00, trophy. 2nd runner-up will receive \$50.00, trophy. Miss Congeniality – Plaque.
18. The winner of Miss Ewing-Fleming County Fair will represent Ewing-Fleming County Fair at the opening day activities of the Kentucky State Fair in Louisville, Kentucky and assist with the Little Miss and Mister pageant in August 2009.
19. Contestants are eligible to enter from all counties in Kentucky.
20. Ewing-Fleming County Fair will pay the winning Miss Ewing Fleming County Fair's hotel room for two nights at state pageant.
